3. HAZARDS IDENTIFICATION:

Harmful by inhalation, in contact with skin and if swallowed. Limited evidence of a carcinogenic effect. Harmful: possible risk of irreversible effects through inhalation, in contact with skin and if swallowed. Carcinogen Category 3.

4. FIRST AID MEASURES:
