### 3. HAZARDS IDENTIFICATION:

Highly flammable. Irritating to eyes and skin. Very toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment. Harmful: may cause lung damage if swallowed. Vapours may cause drowsiness and dizziness.

### 4. FIRST AID MEASURES:

**INHALATION:** Move the exposed person to fresh air at once. Keep the affected person warm and at rest. Get prompt medical attention. Get medical attention if any discomfort continues.

**INGESTION:** DO NOT INDUCE VOMITING! Remove victim immediately from source of exposure. Rinse mouth thoroughly. Provide rest, warmth and fresh air. Get medical attention immediately!

## 5. FIRE FIGHTING MEASURES:

**EXTINGUISHING MEDIA:**

Fire can be extinguished using: Foam. Dry chemicals, sand, dolomite etc.

**SPECIAL FIRE FIGHTING PROCEDURES:**

Avoid breathing fire vapours. Cool containers exposed to flames with water until well after the fire is out. Keep run-off water out of sewers and water sources. Dike for water control.

## 6. ACCIDENTAL RELEASE MEASURES:

**SPILL CLEANUP METHODS:**

Extinguish all ignition sources. Avoid sparks, flames, heat and smoking. Ventilate. Clean-up personnel should use respiratory and/or liquid contact protection. Absorb in vermiculite, dry sand or earth and place into containers.

## 7. HANDLING AND STORAGE:

**USAGE PRECAUTIONS:**

Avoid spilling, skin and eye contact. Keep away from heat, sparks and open flame. Ventilate well, avoid breathing vapours. Use approved respirator if air contamination is above accepted level. Use explosion proof electric equipment.

**STORAGE PRECAUTIONS:**

Flammable/combustible - Keep away from oxidizers, heat and flames. Keep in cool, dry, ventilated storage and closed containers. Keep in original container.
